Stable Owner Agrees That

1. She will provide a box stall for stabling or a shelter for the horse described above.
2. She will provide safe turnout and a turnout shelter for the horse described above.
3. She will provide daily stall cleaning/bedding, feed, water, and turnout. The Stable Owner will care for the horse in a responsible manner.
4. She will permit Horse Owner access to the property and facilities at the discretion of the Stable Owner, any days at reasonable hours.

Horse Owner Agrees That

1. He/She will provide a copy of the current records of inoculations, shoeing and worming program.
 2. He/She will pay Stable Owner the sum of \$250 outdoor board or \$300 stable board for stabling, use of facilities and care and feeding of horse, payable by post dated cheques made out to Sally Welsh for the current year.
 3. He/She will not hold Stable Owner responsible for the loss of the horse above and for the loss of any personal property belonging to Horse Owner due to any and all causes including fire and theft, and acknowledge that insurance coverage for said horse and property is the responsibility of Horse Owner.
 4. He/She will hold Stable Owner free from all damages or liability for any injury to self or other person(s) or properties while at the facility of the Stable Owner.
 5. Horse Owner will be a member of the OEF in good standing.

Horse and Stable Owner Mutually Agree That

1. In the event the horse described above shall require unscheduled or emergency services, Stable Owner will immediately contact Horse Owner. In the event Horse Owner cannot be reached, Stable Owner is hereby authorized, as agent for Horse Owner, to acquire said services, with no liability whatsoever on the part of the Stable Owner for Veterinarian services performed and fees incurred for said services, Veterinarian trailers service, if necessary.

2. Any vandalism or disturbances caused by the Horse Owner, or any person(s) accompanying Horse Owner while on the premises of Fox Hollow Stables, will be grounds for immediate termination of this Agreement, and Horse Owner will be held liable for any and all damages incurred, including loss of business.

3. Horse Owner will respect the rights of others at the farm and will not take any liberties in using equipment or horses, other than his/her own.

4. It is the responsibility of the Horse Owner to turn his/her horse back out in the field they found the horse, or put back in stall unless otherwise discussed with Stable Owner. Halters must never be left on horses in the field or in the stall.

5. Horse Owner agrees to clean up their own mess, turnout lights and securely close doors and gates when leaving.

6. Dogs are not permitted to run loose on Fox Hollow Stables property other than those owned by the farm, without permission of the Stable Owners.
